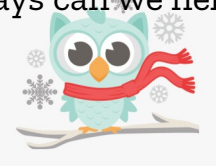

Will you help us help you? ...

- * **The following items are imperative for Chapter administration!**
 - All Chapter secretaries **MUST** have an email address and phone number on file with FMCA!
 - Chapter contact – must be someone who will quickly respond to inquiries.
 - Chapter and Area Secretaries – **shall report new chapter officers within 30 days of an election**, per the National Bylaws, Article XVII, (8), and Policy and Procedure #3020, Chapter Secretary's Responsibilities.
 - Please check your chapter description and make sure it is up to date. We recommend it be very short; no more than five sentences. Members looking for chapters may only read the first two sentences unless they are looking for your specific chapter!
 - Copilots **MUST** be on the membership records to be covered by FMCA Assist! This is FMCA's medical emergency and travel assistance program. Please ask your members to update their membership record. If a copilot is not listed in FMCA's records, *they are not covered by the policy!*
 - Would you be interested in chapter officer educational videos? We are trying to explore new ways to help chapter officers. If we keep the videos short, would you be interested in watching? What should we cover in the videos? What other ways can we help you?



Rallies are Supposed to be FUN!

After all, that's why you have the RV anyway - to have fun! Getting together with friends is a bonus. When you get together, it's nice to see long-time friends and meet new ones too. Each of FMCA's chapters has its unique qualities. There are so many types of chapters, and chapter rallies. Does your chapter have potlucks? Does your chapter play games?
